PUBLIC COMMENT

Gary Slotnik, Hunts Point resident addressed the Council. Following up on discussion that took place during the January Council meeting, Mr. Slotnik asked if WSDOT will be replacing the dead trees along Fairweather Basin this fall. The Town has provided WSDOT will any and all information they had requested and are waiting on a response from WSDOT. The Council assured Mr. Slotnik that they too want any dead planting be replaced as soon as possible.

STAFF REPORTS

Medina Police Department

On June 14th, Medina Police attested a suspect involved in multiple car prowls that occurred days earlier. The suspect was in possession of several items taken during the prowls. The crimes occurred throughout Medina, primarily along Evergreen Point Road. John Kane has retired and Chief Burns informed the Council that his position will be filled internally. At the Council's request, Chief Burns will contact Seattle Marine Patrol and invite them to attend an upcoming Council meeting.

Staff

Clerk Treasurer Sue Ann Spens is still waiting to receive remaining bids for the Town Hall maintenance work which was budget for up to \$40,000. Mrs. Spens is also waiting for more details about the condition of the tennis-court surface. If something more than minor repairs are needed, the Council can amend the CIP/TIP to include the additional costs or pay for them through the operating budget.

PUBLIC HEARING: Ordinance 531, the 2018-2023 Capital Improvement Plan and Transportation Improvement Program (2018-2023 CIP/ TIP) – for approval

Each year, the Town prepares a six year Capital Improvement Plan and Transportation Improvement Program and approves it by July 31st (deadline established by the Puget Sound Regional Council). The Town however is not mandated to complete the projects.
